- Engaging with older people to identify the areas of concern to them; and
- Supporting projects which will tackle these concerns for older people.

who is age sector platform?

Age Sector Platform represents the interests of older people in Northern Ireland. It supports older people to make their voice heard on the issues that matter to them. Its aims are:

- To engage with older people, allowing them to make their voice heard
- To enable older people to advocate on their own behalf
- To empower older people so they can change their lives for the better

It is the charity responsible for the Northern Ireland Pensioners Parliament.

why is a pensioners trust needed?

With around 360,000 people aged 60 and over living in Northern Ireland, it is vital that their voices are heard, respected and acted upon.

- 4 out of 5 pensioners in Northern Ireland are worried about keeping warm in winter
- 2 out of 3 pensioners are fearful of becoming a victim of crime
- 2 out of 3 pensioners are concerned about the price of food
- 1 in 4 pensioners feel lonely.

With reduced Government spending and an increasing number of older people, it is essential that resources are made available to engage, enable and empower the older population; and that resources are dedicated to tackling problems that are not currently being addressed by others.
